

Commentary - April 24, 2024

Based on the average of the CANNEX PAY Index yields, someone investing \$100,000 into an immediate income annuity can expect a payout of \$621 per month for a yield of 7.46%. This is an increase of approximately \$150 per vear since Mar-27-2024.
